



## **OFFICIAL TERMS AND CONDITIONS OF THE BOUNTY CAMPAIGN**

PLEASE READ THESE TERMS CAREFULLY. BY PARTICIPATING IN THE BOUNTY CAMPAIGN, YOU AGREE TO BE BOUND BY THESE TERMS AND ALL TERMS INCORPORATED BY REFERENCE. IF YOU DO NOT AGREE TO THESE TERMS THEN DO NOT PARTICIPATE IN THE BOUNTY CAMPAIGN.

These terms and conditions (“Terms”) cover your participation in the PrepayWay Blockchain Ecosystem Bounty Campaign (“Campaign”). These Terms are between you (“Participant”) and PrepayWay Systems Estonia OÜ. By participating in the Campaign in any manner, you accept these Terms.

### **BACKGROUND**

PrepayWay Systems Estonia OÜ (“Campaign Manager”) is managing an official bounty campaign for the supporters of the PrepayWay Blockchain Ecosystem.

The Campaign will continue until 05.05.2019.

Participation in the Campaign is subject to the rules and regulations as published on the internet page: <https://bitcointalk.org/index.php?topic=5087072>. Participation in the Campaign can also result in the opportunity to get stakes.

InBit tokens allocated for the Campaign will be generated by the Subsidiary of PrepayWay AG (“Token Generator”) within 30 days following the end of the Token Sale. Tokens will be distributed among the Participants in the Campaign from allocated pools in proportionality to the number of stakes each of the Participants has earned relative to the total number of stakes awarded during the particular campaign (e.g. TWITTER CAMPAIGN, FACEBOOK CAMPAIGN,

etc). If the number of actual participants in any given campaign is lower than the maximum number of participants, the pool for this campaign is reduced proportionally. All allocated pools will be subject to specific rules and regulations published on internet page <https://bitcointalk.org/index.php?topic=5087072>

The name of the Token Generator responsible for the generation and distribution of InBit tokens will be announced immediately prior to TGE.

The Campaign Manager is not generating or distributing InBit tokens. The Token Generator has the right to terminate token distribution for an individual or for all participants at any time according to the Token Generator's sole and absolute discretion (without giving reasons), including including without limitation the following:

1. in connection with any failure to complete KYC ("Know your customer") process;
2. in connection with an adverse change of the regulatory environment.

If the Token Generator is required to take any of the actions referred to above, the Participant understands, and agrees with the Token Generator, that it has no claim against the Token Generator, the Campaign Manager, and their respective affiliates, directors, members, partners, shareholders, officers, employees, advisors, delegates, subcontractors, and agents (whether existing or in the future) for any of damages that may result from any of those actions.

### **RESTRICTED JURISDICTIONS**

The Participant (i) is not a citizen or entity of; (ii) was not formed in; (iii) does not reside in; (iv) is not located in; (v) does not have a place of business in; and (vi) is not conducting business in (any of which makes the Participant a "Resident") the United States of America, Switzerland, or any of the following: Afghanistan, Bosnia and Herzegovina, Central African Republic, Cuba, Democratic Republic of the Congo, Democratic People's Republic of Korea (North Korea), Eritrea, Ethiopia, Guinea-Bissau, Iran, Iraq, Libya, Lebanon, Somalia, South Sudan, Sudan, Syria,

Uganda, Vanuatu, Yemen, and the Crimea region or any of their respective states, provinces, territories and possessions or any other nation subject to countrywide or territory-wide sanctions authorized by the United Nations (each a Restricted Jurisdiction).

### **PUBLIC RECOGNITION**

The Campaign Manager may publicly recognize individuals who have been awarded stakes. The Campaign Manager at its own discretion may recognize a Participant on web properties or other printed materials unless the Participant explicitly informs the Campaign Manager of their opting out of this.

### **RIGHT TO TERMINATE**

The Campaign Manager reserves the right to terminate this Campaign for an individual or for all Participants engaged in any unlawful activities including but not limited to the following:

### **FAILURE TO PASS KYC PROCEDURE**

Participants are required to complete the KYC procedure as per PrepayWay's Privacy Policy to be able to receive the tokens.

### **AGE RESTRICTION**

All Participants wishing to participate in this Campaign managed by the Campaign Manager have to be at least 18 years or older.

## **NON-COMPLIANCE**

Non-compliance with the rules and regulations will result in not getting any stakes and exclusion from participation in the Campaign.

## **AMENDMENTS TO CAMPAIGN**

The Campaign Manager reserves the right to make any changes to the Terms and the specific rules and regulations of each allocated pool at any time.

## **WEEKLY REPORT**

All Participants of this Campaign are under a contractual duty to provide a report during the week for which they are completing a designated task. A week for matters of interpretation here means Monday to Sunday (inclusive).

## **FORCE MAJEURE**

The Campaign Manager and the Token Generator will not be liable for any delay, interruption or failure in the provisioning of services if caused by acts of God, declared or undeclared war, fire, flood, storm, slide, earthquake, power failure, the inability to obtain equipment, supplies or other facilities that are not caused by a failure to pay, labor disputes or other similar events beyond our control that may prevent or delay service provisioning.

## **INDEMNIFICATION**

You hereby indemnify PrepayWay AG, the Campaign Manager, the Token Generator, and their affiliates, sponsors, partners, directors, officers, and employees and undertake to keep PrepayWay AG, the Campaign Manager, the Token Generator, and their affiliates, sponsors, partners, directors, officers and employees indemnified against any losses, damages, costs, liabilities, acts of God, and expenses (including without limitation legal expenses and any amounts paid by PrepayWay AG, the Campaign Manager, and the Token Generator to a third party in settlement of a claim or dispute on the advice of the legal advisers of PrepayWay AG, the Campaign Manager, and the Token Generator) incurred or suffered by PrepayWay AG, the

Campaign Manager, the Token Generator, and their affiliates, sponsors, partners, directors, officers, and employees arising out of any breach by you of any provision of these terms and conditions or arising out of any claim that you have breached any provision of these terms and conditions.

#### **WAIVER**

No waiver of any of the provisions of this Agreement will be deemed to constitute a waiver of any other provision nor shall such a waiver constitute a continuing waiver unless otherwise expressly provided in writing duly executed by the party to be bound thereby.

#### **ASSIGNMENT**

The Campaign Manager may transfer, sub-contract or otherwise deal with its rights and/or obligations under these terms and conditions without notifying you or obtaining your consent.

#### **SEVERABILITY**

If a provision of these Terms is determined by any court or other competent authority to be unlawful and/or unenforceable, the other provision will continue in effect. If any unlawful and/or unenforceable provision would be lawful or enforceable if part of it were deleted, that part will be deemed to be deleted and the rest of the provision will continue in effect.

#### **GOVERNING LAW**

This Agreement will be governed and construed in accordance with the laws of Switzerland, and any claim or dispute relating to these terms and conditions will be subject to the non-exclusive jurisdiction of the Courts of Switzerland. For the avoidance of doubt, these Terms do not include any alternative dispute resolution procedures as a means of disrupting or issuing any claims in relation to these Terms.

**ENTIRE AGREEMENT**

These Terms constitute the entire agreement between you and the Campaign Manager in relation to the use of the website and subsequent services and supersedes all previous agreements in respect of your use of this website.
